This report is designed to give water consumers of **Wildwood on Pink Mountain Subdivision** information on their water quality and the testing carried out in 2016. Included in this report is information about where your water comes from, what it contains, and how it compares to standards set by regulatory agencies. **American Water Services, Inc.** is committed to providing clean, safe, and reliable drinking water for all. Your water comes from 3 wells drilled deep into rock aquifers. The water from these wells is treated with a small amount of chlorine for disinfection.

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk of infections. These people should seek advice about drinking water from their health care providers. Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in source water include the following:

**Microbial contaminants*, such as viruses and bacteria which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.

**Inorganic contaminants*, such as salts and metal, which can be naturally occurring or result from urban storm runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.

**Pesticides and herbicides*, which may come from a variety of sources such as agriculture, urban storm water runoff, and residential uses.

**Organic chemical contaminants*, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production. It can also come from gas stations, urban storm water runoff, and septic systems.

**Radioactive contaminants*, which can be naturally occurring or be the result of oil and gas production and mining activities.

During 2016, the Georgia Environmental Protection Division prepared a Source Water Assessment Plan on the water system in Wildwood on Pink Mountain Subdivision. This assessment lists all potential sources of contamination within a specific radius of all the wells supplying your water system. These potential sources include items such as electrical transformers and utility poles which contain chemicals and preservatives. Also, domestic and non-domestic sewer systems and domestic wells lie within the management area and should be maintained to the standards set by the White County Health Department. Storm water runoff from parking areas as well as access, secondary, and state roads pose the risk of contaminants such as petroleum products, fertilizers, and pesticides. There are also a series of streams that should be monitored for possible contamination as they could be connected to you aquifer. The dumpsters near the well site should be monitored to make sure only solid waste is disposed of in these containers. A pasture and chicken house is located in close proximity to the water system and should be operated at standards set forth by the GA Dept. of Agriculture.

In order to ensure that tap water is safe to drink, EPA prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. Food and Drug Administration regulations establish limits for contaminants in bottled water, which must provide the same protection for public health.

WATER QUALITY DATA

The following tables list all drinking water contaminants that we detected during the 2016 calendar year. The presence of these contaminants in the water does not necessarily indicate that the water poses a health risk. Unless otherwise noted, the data presented in these tables are from testing done January 1 – December 31, 2016. EPD requires us to monitor for certain contaminants less than once per year because the concentrations of these contaminants are not expected to vary significantly from year to year. Some of the data, though representative of the water quality, is more than one year old.

Definition of Terms and Abbreviations Used in this Report

Maximum Contaminant Level (MCL): The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

Maximum Contaminant Level Goal (MCLG): The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

Action Level (AL): The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.

Treatment Technique (TT): A required process intended to reduce the level of a contaminant in drinking water.

Maximum Residual Disinfectant Level (MRDL): The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbiological contaminants.

Maximum Residual Disinfectant Level Goal (MRDLG): The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.

***NA:** not applicable ***ND:** not detectable at testing limit ***ppb:** parts per billion or micrograms per liter ***ppm:** parts per million or milligrams per liter ***pCi/l:** picocuries per liter (a measure of radiation) ***QC:** quality control

Additional Lead Information:

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. American Water Services is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested.
